ACCUSED

Under Section 200 of the Code of Criminal Procedure, the complainant above named, humbly begs to state as follows:

1. The complainant holds a Bachelor's Degree in Hospitality
Management from Wales, United Kingdom. Following his education, he
worked as a Food and Beverage Manager in Shangrila Hotel, a

prestigious Five-star Hotel in Kuala Lumpur for about 2½ years. He then started his own food and beverage business in the heart of the City of Kuala Lumpur. He successfully ran his business for about three years. Following this, he was offered a job in united Kingdom in a renowned food chain of restaurants. He was also active core member in a non-profit organisation called 'Kala Premi" an organisation to promote and revive Indian arts. He first met Nithyananda Swamiji of Nithyananda Dhynapeetam in December, 2008 during a 21-day enlightenment-intensive meditation programme called Inner Awakening. He experienced great transformation during the programme which encouraged his mother and his wife also to attend the programme. He joined the Ashram in July, 2009 along with his wife and mother as a devotee.

2. On the afternoon of 24.02.2011 at about 3-00 P.M., the accused made an attempt to gate-crash into the premises of Nithyananda Dhyanapeetam which is at Nithyanandapuri, Kallugopahalli, Bidadi, Ramanagara District. At that point of time, the complainant had stationed himself along with few others including C.Ws. 1 to 8 near the main entry to the premises of Nithyananda Dhyanapeetam, supervising some construction activity that was going on in the Ashram premises.

On noticing the presence of the accused, Sri Atma Prabhananda, the

Administrative Officer of Nithyananda Dhyanapeetam, sought to know from the accused as to who he is and desired from him to declare his identity before being allowed to get into the Ashram. The complainant, who was also present there, joined the issue with the Administrative officer of the Ashram. The accused who refused to disclose his identity, began to barge into the Ashram premises in a most ferocious manner while shouting at the top of his voice by using below-belt language. It was at this point of time, the complainant and the other in-mates of the Ashram including the Administrative Officer and C.Ws. 1 to 8 again made an attempt to know about the identity of the accused as the accused was a total stranger to the Ashram and as he was not known to anyone in the Ashram including the complainant and others who were present then near the main entry to the Ashram premises.

3. The accused, on noticing the complainant who was standing right in front of him, fell foul upon the complainant and assaulted the complainant with his hands. He pushed the complainant hither and thither. He also held the right hand of the complainant and twisted it in most brutal manner. When the accused man-handled the complainant in the manner stated above, the kurtha which the complainant was wearing, also came to be torn.



- (a) The accused threatened the complainant and his fellow Ashramites who were present over the place of incident, of being kicked and arrested if his identity were to be questioned again and again. The accused also threatened the complainant and his fellow Ashramites who were present then of being lugged into some Criminal case or the other, while saying, that he is Ramalingappa, an official attached to the State C.I.D., Bangalore. A portion of the incident of assault came to be Videographed by the complainant by using the mobile phone which he was having in his hands at that point of time.
- 4. Sometime later, the accused who had come in a motor vehicle, left the place fearing that serious consequence may emanate if his presence in the premises of the Ashram were to continue any further.
- 5. The complainant, who had suffered excruciating pain in his right wrist and who also noticed swelling in his right wrist, fearing injury either to the nerve in the right wrist or fracture of right wrist bone, was immediately taken to Subhas Medical Centre, B.M. Road, Bidadi, which is close-by to the Ashram for medical check-up and treatment. Dr. Subhas K., Medical Director and an Orthopaedic Surgeon who were available in the Medical Centre, examined the complainant, gave him the treatment needed for the injuries which he had sustained and put his right wrist under plaster-cast. He was also advised to take medicines for

elieving of the pain with which he was suffering from while advising him take rest for three weeks and immobilised his right hand under plaster-cast.

Sri Atma Prabhananda, the Administrative officer of Nithyananda Dhynapeetam and few of his Ashramites rushed to Bidadi police station and presented a complaint before the Officer-in-charge of Bidadi police station and sought for action against the accused. The Officer-in-charge of Bidadi police station refused to receive not only the complaint which came to be filed by Sri. Atma Prabhananda, the Administrative Officer of the Ashram but also refused to go over to the scene of offence, let alone, making any attempt to know anything about the incident in question and about the injury which the complainant had sustained in the incident of brutal assault committed on his person by the accused. Sri. Atma Prabhananda, the Adminstrative officer of the Ashram who did not get dis-heartened consequent to the refusal on the part of the police to receive the complaint filed by him and the refusal to initiate action against the erring accused, went to Kengeri Telephone Exchange and sent Telegraphic complaints not only to the Officer-in-charge of Bidadi police station but also to his higher-ups including the Director General and Inspector General of Police, CID, Carlton House, Palace Road, Bangalore, seeking action against the accused while indicating in the

elegraphic complaint in brief about the incident of assault on the person the complainant.

- (a) The complainant has produced herewith (i) the Out-patient slip, ssued by Subhas Medical Centre, (ii) the Wound Certificate issued by the Doctor who treated him for the injury which he had sustained, Copies of the telegraphic complaints addressed to the Station House Officer, Bidadi police station and his immediate higher-ups, (iv) Postal receipts evidencing the despatch of telegraphic complaints and Video Cassette of the scene of incident, for ready reference.
- From the course of his conduct, the accused has committed serious offences which are made penal under Sections 323, 327, 352, 355, 447, 448, 506 of the Indian Penal Code.
- 8. The Bidadi police have not only not chosen to receive the complaint in relation to the incident in question but have also not chosen to initiate any action whatsoever against the erring accused despite the information of the incident in question being given to them orally and through a Telegraphic Complaint after they refused to receive the written complaint. The Bidadi police have not chosen to even visit the complainant and make enquiries with him, let alone, getting the

emplainant any further treatment needed for the injuries which he had ustained in the brutal assault on his person by the accused.

The complainant has absolutely no faith whatsoever with the Sdadi police. The complainant is certain that the Bidadi police would not ensure justice to him in the matter. It is for this reason that the complainant has presented this complaint before this Hon'ble Court seeking action against the erring accused.

Therefore, the complainant above named, humbly prays that this Hon ble Court be pleased to secure the accused and deal with him in accordance with law, in respect of the offences, committed by him and which are made penal under Sections 323, 327, 352, 355, 447, 448, 506 of the Indian Penal Code.

(a) The complainant further prays that he be compensated such sum as is found justified, in exercise of the jurisdiction vested under Section 357 of the Code of Criminal Procedure, by an order against the accused, in the ends of justice.
