- I, DR. UMAKANT KHETAN, declare as follows:
- 1. I have over 36 years of experience as an urologist. My full Curriculum Vitae, Exhibit 1, is attached.
 - a) I completed my MBBS from KEM Hospital, Bombay, India in 1973.
 - b) I obtained an MS in General Surgery, which included a Urology residency from KEM Hospital, Bombay, India 1978.
 - c) I completed a formal residency in Urology, at the University of Minnesota in 1982.
 - d) I completed my board certification in Urology in 1986, and my present California license is A-38780, 1982.
 - e) I am a past chairman of The Department of Urology, St. Vincent Medical Centre, LA, California
 - f) I am a Medical Director and advisor to, The National Institute of Clinical Research.
 - g) I have published 15 peer-reviewed articles in International journals.
 - h) I have contributed to 2 book chapters.
- 2. This is my opinion and conclusions with respect to the medical records of Sri Nithyananda Swami, who was examined at Victoria Hospital and institute of Nephro –Urology, in Bangalore -560002, India and the subsequent report given by the examining team at Victoria Hospital in Bangalore, Karnataka. ("Report"). I have had an opportunity to review the attached, Exhibit 2, in preparation of this Report and conclude as follows:
- 3. Sri Nithyananda Swami's tests show that his blood flow to the penis is not normal, which would result in poor erectile function and difficulty in having sexual intercourse.
- 4. His hormone levels are extremely low, which would result in almost No sexual Desire or Libido. This degree of hypogonadism would also affect the

erectile and sexual function of the person, making it very difficult to have sexual intercourse.

- 5. Physical finding of bilateral gynecomastia is further evidence of feminizing characteristics that make the erectile function very poor.
- 6. Further, it takes several years for the hormonal levels of Testosterone to reach anorchid levels and gynecomastia to develop. This indicates a chronic disorder of long standing.
- 7. In the findings relating to the psychiatric and psychological assessment of Sri Nithyananda Swami, there is a clear history of his body being unresponsive to sexual urge, no sexual activity during his lifetime, no history of masturbation, wet dreams or erections. The psychiatric team has not disputed this history in the report, though these findings indicate a psychological cause of Erectile Dysfunction. All they have reported is that Sri Nithyananda Swami has an intact judgment and there was no evidence of psychopathology.
- 8. Notably, there are glaring discrepancies between the actual results of the patient and the conclusion drawn by the board of physicians in the Victoria Hospital report.
- 9. Finally, having long standing diabetes, hypertension and Dyslipidemia, along with the medications one has to take for these conditions, has a significant negative impact on the vascular and neuropathic flow to the penis, again causing significant compromise of the erectile function.
- 10. In conclusion, in my more than 30 years of experience, having seen and treated hundreds of cases of erectile dysfunction, I can say that a person with these objective and subjective findings would most likely, not be able to have spontaneous erections or sexual intercourse.
