I personally viewed each of these clips and they are consistent with what I witnessed each day that the videos depict.
- 8. Based on my personal knowledge and based on my review of these videos, Aarthi Rao was not in attendance at the NSP workshop, which took place from December 1 through December 4, 2015.
- 9. Based on my personal knowledge, Aarthi Rao was never in Nithyananda Dhyanapeetam, Kallugopahalli, Off Mysore Road, Bidadi, Bangalore 562109 on these dates.
