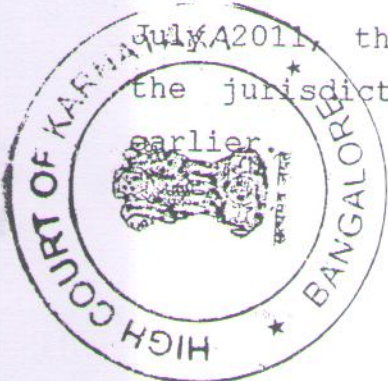

ORDER

Heard learned counsel for the petitioner and Addl. State Public Prosecutor for the respondent. In modification of the order dated 8.4.11 the present order is passed.

The Office by mistake had mentioned the case number Crl.P.No.2329/10 though the application was filed in Crl.P.2328/10 and in this context though the order came to passed on Misc.Crl.No.2233/2011, the State Public Prosecutor had no opportunity to put forth his objections. It is in these circumstances that the objections are considered and the counsel for the petitioner and the Addl.SPP are heard with regard to relaxation of conditions. Taking into consideration the grounds made out, permission is accorded to the petitioner to leave the jurisdiction for the purpose of visiting Manasa sarovar and other places and he shall return back by the end of July 2011. After return from Manasa sarovar by the end of July 2011, the petitioner shall mark his presence before the jurisdictional police once in a month as ordered earlier.



So far as production of publication "Standup for Dharma" and the appending materials referred to therein, learned counsel for the petitioner is permitted to take steps as advised.

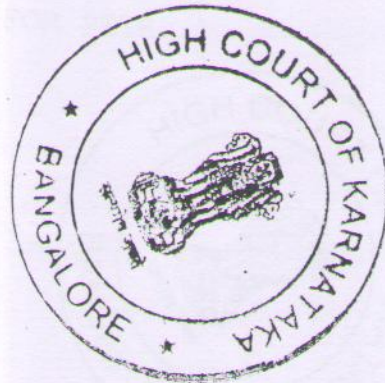
